



WOMEN IN THE WIND SAFE MILEAGE CONTEST 2022—2023 OFFICIAL INDIVIDUAL REPORTING FORM



THIS FORM MAY BE USED BY ASSOCIATES, FOR RENTAL BIKES, OR FOR CHAPTER MEMBERS SUBMITTING THEIR OWN FORMS. FOR CHAPTERS REPORTING MULTIPLE MEMBERS' MILEAGE AT ONCE, INDIVIDUAL FORMS ARE TO BE USED TO CALCULATE MILEAGE BUT PLEASE SUBMIT USING ONLY THE CHAPTER REPORTING FORM LISTING ALL YOUR CHAPTER PARTICIPANTS

ELIGIBILITY

- ◆ Be a member of WITW during some part of the contest term
- ◆ Not be involved in a traffic accident (whether at fault or not) within the contest term
- ◆ Not be disqualified due to late, incomplete or incorrect form.

AWARDS

Each eligible participant receives:

- ◆ "Safe Rider" pin (first year participants)
- ◆ 2022 rocker to attach to "Safe Rider" pin

A plaque will be awarded in each category with at least THREE eligible participants:

- ◆ Top 5 Mileage (Chapter)
- ◆ High Mileage (Chapter Member)
- ◆ High Mileage (Associate Member)

100,000 MILE CLUB

- ◆ Participants whose logged mileage over the years as a member of WITW adds up to 100,000 miles or more will be recognized as a member of this club.

OFFICIAL RULES

- ◆ Participant's membership must be in good standing during the contest. If membership status changes during the contest, the current status on October 31, 2023 applies.
- ◆ Mileage reported must be accumulated solely by the member who submits the form.
- ◆ If more than one bike ridden by a Member is entered in the contest (including rentals), a **separate form** must be submitted for each bike.
- ◆ Beginning **AND** ending mileage must be witnessed and logged by an employee of an authorized motorcycle dealership (holds license to sell motorcycles) or an officer/ safe mileage representative of the Member's chapter. This includes rental bikes.
- ◆ Participant must ride a **minimum of 25 miles** for the year reported.*
 - * Broken odometer must be witnessed and logged by an employee of an authorized motor cycle dealership or an officer / safe mileage representative of the Member's chapter. Members submitting forms indicating their odometer is broken will receive credit for zero (0) miles but are eligible for Safe Mileage pin and rocker.
- ◆ A member involved in a traffic accident during the contest term will not be eligible for Safe Mileage pin and/or rocker but her miles will be recorded for the 100,000 Mile Club.
- ◆ **Beginning mileage must be witnessed no earlier than November 1, 2022.**
NOTE: 2021–22 Safe Mileage participants may use the ending mileage from 2022 form (for the same bike) as the beginning mileage on 2023 form.
- ◆ **Ending mileage must be witnessed no later than October 31, 2023.**
- ◆ *Associate Members Only:* Fill out form COMPLETELY and mail to: **Deb Lussier, WITW Int'l. Secretary, 251 Picketts Trace, Acworth, GA.** Form may also be scanned and emailed to witwsecretary@gmail.com. **CERTIFIED MAIL WILL NOT BE ACCEPTED.**
- ◆ **Forms must be postmarked or emailed no later than Nov. 15, 2023.**
- ◆ Absolutely NO late forms will be accepted for Safe Mileage pins or year rockers.
- ◆ The Chapter Reporting Form is to be used when submitting for multiple participants
